Housing

- Denial of public or subsidized housing
- Evictions
- Foreclosure
- Unsafe Living Conditions
- Lockouts and Utility Shut-offs

Special Populations

- District Long Term Care Ombudsman: Advocating for the rights, dignity, and independence of Nursing Home Residents.

- Senior Health Insurance Program (SHIP): Increasing access to health care by helping Medicare beneficiaries make informed decisions about programs that affect their quality of life.

- Veterans: Helping U.S. Veterans and active military personnel with complex legal issues like access to VA benefits and healthcare, housing and homelessness issues, and employment barriers.

Benefits

- Denial, termination or reduction of government or public benefits. (i.e.: unemployment, Social Security, SNAP)

Consumer Issues

- Bankruptcy
- Consumer Fraud
- Criminal Record expungements
- Debtor Harassment
- Wage Garnishment

Family

- Divorce in cases to protect a person or child from abuse
- Domestic and Interpersonal Violence
- Other family law issues such as **child custody and reunification** when a child's well-being is jeopardized.



To be eligible for free, civil legal help from Legal Aid of the Bluegrass you must:

- Have an income that meets our income eligibility guideline.
- Be a U.S. citizen or eligible undocumented immigrant.
- Have a type of civil case that LABG accepts (see listing in this brochure).
- Reside in or have a legal problem in a county within our service area.
